

INTRODUCTION

Sustainability as a topic increasingly faces challenges in the public debate, but our commitment remains firm. Sustainability is not just a claim for us - it is the very foundation of our business. It shapes our decisions, drives our innovations, and defines our purpose. And we are proud of this.

Our HS Timber Group Sustainability Report 2024 is a reflection of the company's ongoing commitment to environmental stewardship, responsible governance, and social impact.

Since 2018, we have voluntarily reported on our sustainability initiatives. In 2023, we took a proactive step by adopting the European Sustainability Reporting Standards (ESRS), even though we are not required to do so. While we recognize the upcoming regulatory changes introduced during the Omnibus debate, we have chosen to maintain the established reporting structure. The consistency allows us to clearly communicate both our progress and challenges we face on our sustainability journey.

The following pages summarize the key figures, accomplishments and commitments of our Sustainability Report 2024.

ENVIRONMENT

- + 91% of total energy consumption comes from renewable sources
- + 87% share of own-produced renewable energy of total energy consumption
- + 4 GWh electricity generated by our photovoltaic plants (Comănești, Kodersdorf)
- + 3 of our sawmills equipped with combined heat and power plants for green power generation

Sustainable Investments

At HS Timber Group, we are proud to work with a truly sustainable resource: wood. By using it efficiently - both in our products and for energy production - we minimize waste and keep the greenhouse gas emissions from our operations comparatively low.


CLIMATE CHANGE

Still, we have established ambitious goals in addressing climate change. Our focus areas are the increase of GHG emission-free electricity in the purchased electricity mix, the further expansion of own renewable energy generation, and the reduction of fossil fuels by efficiency measures and transition of vehicle fleet from fossil fuel powered to full electric vehicles. For 2024, we have calculated our full Corporate Carbon Footprint for the second consecutive year, reinforcing our commitment to climate action.

Notably, the share of renewable sources in our total energy consumption increased to 91% in 2024, reducing the proportion of non-renewable energy. Major part of this renewable energy is own-produced through our combined heat and power plants and boilers that are fueled with sustainable biomass.

HS Timber Group remains committed to environmental protection through the implementation of an Environmental Management System (EMS) that promotes recycling, energy efficiency, and sustainable resource use.

HS Timber Group's operations are an integrative part of a bio-based circular economy.

HS Timber Group's primary product - wood - does not only play a crucial role in climate change mitigation by storing carbon dioxide throughout their lifespan but is most importantly a renewable resource. By maximizing material efficiency and enabling the reuse, recycling and repurposing of wood products, we are reducing waste and conserving natural resources.

We are fundamentally committed to the consecutive and cascading use of resources, always prioritizing product utilization which creates the highest value added in circular economy practices. We don't just produce solid wood. Our production process also generates valuable by-products, which we supply to the further processing industry or use in pellet production for both industrial and end customers.

HS Timber Group's target is to specifically focus on the efficient use and sustainable sourcing of raw materials.

In the long run, we believe wood is far too valuable to be simply burned. That's why, together with our partner, the Technical University of Vienna, we are investing in the large-scale research project Woodcomp3D to develop a new wood-based material from by-products, one that could be used in the construction of the future.







Sustainable sourcing is essential to maximizing the sustainability value of wood as a renewable resource. A core concern for the company is here to ensure the legality of all its input. Over the years, HS Timber Group has developed and implemented an advanced and robust Due Diligence System (DDS) for all mills, allowing the company to monitor and manage risks in its supply chain. Additionally, certifications for sustainable forest management plays a key role in the commitment to responsible forest practices.

We are committed to purchase all our material from certified forest areas by 2030.

Since 2017, our own developed GPS-based Timflow system has ensured full physical traceability across the Romanian supply chain, setting a benchmark for transparency and accountability in the wood industry. Now, with the new regulatory requirements resulting from EUDR (EU Deforestation Regulation) we modernize and update our digital infrastructure to stay well ahead of pure compliance but really to make the difference.



- + 75% of roundwood from certified forests in 2024 (new sourcing areas in Argentina were under the certification process but not yet certified)
- + 3 mills certified according to SURE SUSTAINABLE RESOURCES Verification Scheme







- + Stakeholder engagement with forest owners of our Finnish sawmill in Luvia




At HS Timber Group we acknowledge the importance of our impact on various stakeholders, including employees, business partners, local communities, authorities, NGOs, and media.
